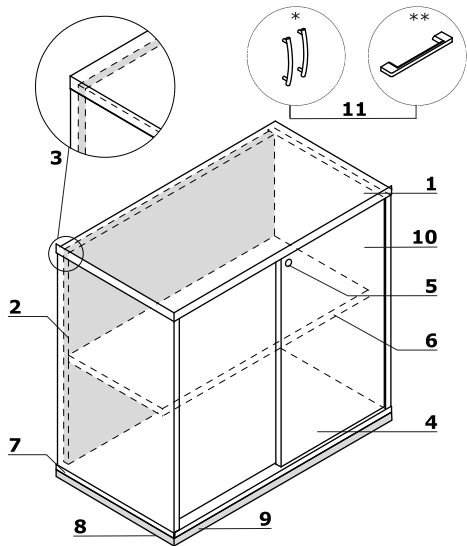

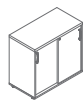

- 7. Base - MFC 18 mm, ABS edge
- 8. Leveling feet 27 mm - range 12 mm

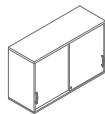
Stack-on storages with sliding door *

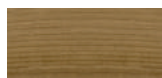

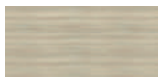
